**Emily Janoski-Haehlen**

**Assoc. Dir. for Law Library Services, Northern Kentucky University, Salmon P. Chase College of Law**

**Assistant Professor of Law Library Services**

Professor Janoski-Haehlen works at the NKU Chase Law Library since 2003. As Associate Director for Law Library Services, she is in charge of the law library in the director's absence and participates in collection development and overall administration of the library. She is also responsible for posting the Kentucky Supreme Court and Court of Appeals Briefs on the law library's website and providing reference assistance. Professor Janoski-Haehlen is in charge of the digital repository of Chase faculty publications and works with the Chase law faculty in posting their legal papers and other work on the Social Science Research Network. She teaches Basic Legal Skills Research, Advanced Legal Research, and coaches the Adoption Law moot court team.

She received her B.S. from the University of Kentucky, her Juris Doctorate from the Salmon P. Chase College of Law, and her Master's of Science in Library and Information Science from the University of Kentucky.

Emily has been an active member of ORALL since 2003, and she is currently serving on the local arrangements committee for the upcoming meeting in Cincinnati.

**Treasurer****Rick Goheen****Director, University of Toledo College of Law Library**

Rick Goheen has been director of the law library and assistant professor of law at the University of Toledo since 2007. Prof. Goheen received all three of his degrees from ORALL institutions, progressively further south along I-75: a bachelor's in political science from Toledo, then a JD from Cincinnati, and finally his MSLS from Kentucky. He is an occasional contributor to *Law Librarian Blog*. While working at the UC law library, he served as treasurer for his local church and an elementary school PTO.
