Indiana Statistics Aggregators	Governmental Statistics
<p>Stats Indiana</p> <ul style="list-style-type: none"> • View stats by region or topic • Topics range from population, birth and death records to workforce stats <p>Hoosiers by the Numbers</p> <ul style="list-style-type: none"> • View stats by region or topic • Topics range, but focus particularly on labor/employment and education <p>Indiana State Data Center</p>	<ul style="list-style-type: none"> • Most governmental entities keep and publish statistics annually. Examples include: <ul style="list-style-type: none"> • Indiana Trial Court Statistics • Indiana Agencies • Indiana Secretary of State – voter statistics • Indiana Transparency Portal
